Chief Deputy Lucas County Engineer Jeff Lohse had contacted the Fiscal Officer Kay Ann Robertson that everything is in place to advertise for the 0.55 mile Davis Road Project in Waterville Township:

RESOLUTION #2011-14 TO APPROVE PLANS AND GRANT PERMISSION TO ADVERTISE FOR BIDS FOR THE DAVIS ROAD PROJECT - #CL090.

Mr. A. Leslie Disher moved to adopt the following Resolution #2011-14:

**WHEREAS**, Waterville Township has been approved by the Ohio Public Works Commission (OPWC) to make improvements to 0.55 miles of Davis Road between Weckerly Road and Obee Road; now therefore,

**BE IT RESOLVED**, by the Board of Trustees of Waterville Township, Lucas County, Ohio, that:

Section 1: The Trustees have approved the project plans, specifications and cost estimate. The Fiscal Officer of this township is directed to publish in the newspaper ("The Blade") of general circulation, "Notice to Bidders", for the Davis Road Resurfacing Project #CL090, upon completion and receipt of the bid documents from the Lucas County Engineer's Office.

Section 2: The Trustees have received the bid documents from the Lucas County Engineer's Office and a "Notice to Bidders" will be published in "The Blade" on January 5, 2012. Bid opening is set for January 25, 2012, at 7:35 pm at the Waterville Township Hall, 621 Farnsworth Road, Waterville, Ohio. The contract will be awarded at the regularly scheduled Trustees' meeting on February 22nd beginning at 7:30 pm. Estimated cost of the project is \$299,794,15. Costs will be covered with a grant for one-half (1/2) from OPWC and the remainder from the Township Road and Bridge Fund.

Section 3: This Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board and that all deliberations of this Board that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 4: This resolution shall be in full force and effect from and immediately upon its adoption.

3) A letter had been received from Bob Neubert, Lucas County Engineer Certified Technician. It was brought to his attention that there is some development going on in the townships that does not require a permit from the Lucas County Building Regulations; namely, fences, pools, ponds, etc. He is stating that the floodplain status should be verified before issuing the permit. Floodplain development permits are \$50 for residential and \$75 for commercial. He would like for all of the permits issued in 2011 to be reviewed by his office. Apparently one of our townships made a serious mistake. Inspector Gay will talk to Planner Maguire about the situation.

4) Kirk Hester, 8507 Dutch Road, Waterville, Ohio, has a "Home Occupation" permit to operate his general construction business from his residence at the above location with the understanding that his equipment would not be in the open but stored under roof. If he cannot store his equipment inside, he will have to look for a commercial area for his business. Both Inspector Gay and Property Standards Officer Fischer will be working on this issue.

5) Recently, Inspector Gay spoke to D.J.Mears, who works for the Lucas Soil and Water District and is in charge of the animal waste composting facility at the Blue Creek Metro Parks on Schadel Road. They have a couple of customers, namely, Bittersweet Farms, which has an equestrian center and arena and another customer. The facility is not as popular as was anticipated.

PROPERTY STANDARDS:

1) Property Standards Officer James Fischer submitted the Architectural Review Board (ARC) minutes for November and December. He also submitted the attendance record for 2011 for payment.

2) It has been a quiet month - No complaints.

3) There have been two phone calls from Dale Myers concerning the blighted lot in front of the Kroger store on SR 64. Mr. Myers states that all of the details have been worked out and the developer is free to begin cleanup.

3) Things are progressing on schedule for final draft for the Architectural Standards for the SR 64 Overlay District.

4) Mr. Fischer attended Waterville's Comprehensive Plan Update meeting held on December 13, 2011. They had a power-point presentation followed by an electronic survey during which audience members participated.

SOLICITOR:

1) Solicitor Walt Celley presented his 2012 law director contract for the trustees to take action on at their 2012 Organizational meeting.

2) The trustees had been given a draft copy of a resolution concerning the regulation of peddlers and solicitors in the unincorporated portion of Waterville Township:

RESOLUTION #2011-15 CONCERNING THE WATERVILLE TOWNSHIP TRUSTEES' REGULATION OF PEDDLERS AND SOLICITORS IN THE UNINCORPORATED PORTION OF WATERVILLE TOWNSHIP.

The Board of Trustees of Waterville Township, Lucas County, Ohio met in regular session of the Board on December 28, 2011 at 7:30 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:

**WHEREAS**, in consideration of the public health, safety and welfare, the Board of Trustees finds it appropriate to regulate the activities of peddling or soliciting with the unincorporated area of the Township; and,

**WHEREAS**, the proceedings and hearings on this Resolution and any necessary notices of such proceedings and hearings have all been undertaken, conducted and given in accordance with applicable law: now therefore,

**BE IT RESOLVED**, by the Board that the following policy shall be and hereby is adopted as a Resolution of the Board:

1. DEFINITIONS

(a) "Peddling" or "soliciting" unless expressly provided for otherwise, means traveling from residence to residence within the Township, without having a previous appointment to visit the residence or residences visited for the purpose of exposing or offering for inspection or sale, goods, wares, merchandise, foodstuffs or any other property, tangible or intangible, of any nature whatsoever, or services, or for the purpose of taking or attempting to take orders for the purchase of goods, wares, merchandise, foodstuffs or other property, tangible or intangible, of any nature whatsoever for future delivery, or of services to be furnished or performed in the future. "Peddling" or "soliciting" does not mean the soliciting of funds or other property for charitable purposes at any residence within the Township. The solicitation by a newspaper carrier of customers for a newspaper which he/she regularly delivers or will regularly deliver shall not be included in this definition, nor shall solicitation for political purposes be included in this definition.

(b) "Peddler or "solicitor" means any person who engages in peddling or soliciting.

2. REGISTRATION REQUIRED

No person shall peddle or solicit within the Township without first registering with the Division of Police. A separate registration must be made for every peddler, solicitor, agent or employee soliciting within the Township.

3. INFORMATION TO BE FURNISHED

(a) Each peddler or solicitor shall, prior to the time of commencement of solicitation furnish the Division of Police with the following information on forms provided by the township.

- (1) Name and date of birth of applicant.
(2) Complete permanent and local address of applicant.
(3) Name and address of the person, firm, corporation or association for whom the solicitation is being made.
(4) A description of the nature of the business and the goods, services or wares to be sold or otherwise sufficient to identify the subject matter of the soliciting in which the applicant will engage.
(5) The proposed dates and times of the solicitation and the routes to be followed in conducting same.
(6) The make, model, year, color, and license plate number of automobiles used by the applicant during the period of solicitation within the Township and the number of the applicant's driver's license and state of issuance.
(7) Such information shall only be valid for six (6) months from the date of its furnishing to the Division of Police.

4. RULES AND REGULATIONS

Every person to whom this Resolution applies shall be governed by the following rules and regulations:

(a) All circulars, samples or other matter shall be handed to an occupant of the property or left in a secure place on the premises.

(b) No person subject to the provisions of this Resolution shall peddle or solicit, except between the hours of 9:00 a.m. and 7:00 p.m. Eastern Standard Time or Eastern Daylight Time.

(c) No peddler or solicitor shall enter or attempt to enter the house, apartment or other dwelling unit of any resident in the Township without an express invitation from the occupant of the house or apartment.

(d) No person subject to the terms of this Resolution shall make any false, fraudulent, misleading or deceptive statement during the course of that person's soliciting activity within the Township.

(e) No person subject to this Resolution shall make any solicitation where peddlers or solicitors are notified by a sign that soliciting is prohibited.

(f) No peddler or solicitor shall engage in or transact any type of business or solicitation other than that specified on the registration certificate.

(g) No person while engaged in any for profit solicitation, shall knock at the door or ring the bell of any home, apartment, apartment building or other dwelling unit in the Township upon which is displayed at the entrance a notice that reads "No Peddlers or Solicitors Allowed", or which otherwise clearly purports to prohibit peddlers or solicitors on the premises, unless such peddler or solicitor is, or has been invited upon the premises by the owners, lessee or occupant thereof.

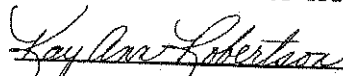

3) John Minear, Waste Management of Ohio, sent a notice that the Lucas County Solid Waste Management District's new contract would become effective 01/01/2012. Fees would go from \$3.20 per ton to \$5.20 per ton. Rates per unit shall increase to \$0.26 per unit per month..

4) Solicitor Celley and Chairman Disher have not met with the City of Waterville concerning the JEDD. Solicitor Celley states he is recommending that all parties sit down together at the same table.
